

**AFSC LIVE FIRE/EXTRICATION COMPLIANCE ELIGIBILITY FORM

Live Fire/Extrication Certification Examination Eligibility Compliance Methods

Practical skills from the Fire Fighter I and II course are used for the selection of final examination requirements and job performance requirements include vehicle extrication and fire attack skills. For testing safety an alternative compliance method is required during training instruction.

Live Fire/Extrication Certification Eligibility Compliance Methods:

The Primary Course Coordinator for the course is required to conduct live burn skills and a vehicle extrication exercise during training. The following procedure shall be followed during an approved course to fulfill the live burn or extrication test skill:

1. Before conducting a live burn exercise and/or vehicle extrication as required during the course, the Primary Course Coordinator should contact the Alaska Fire Standards Council, or AFSC designated Evaluator, and indicate the date and location of the live burn and vehicle extrication exercise.
2. An approved AFSC Evaluator will be present and observe the live burn exercise and/or vehicle extrication to determine successful completion of the required skills as specified on the practical skills checklists in each candidate's Practical Skills Book. Practical skills checklists provide the specific steps to be accomplished for each type of live burn and vehicle extrication. This evaluator must not be an instructor for the course being taught. This evaluator shall observe as candidates enter a compartment for interior fire attack and observe candidate tactics used to control a fire.
3. The AFSC Evaluator present for the live burn exercise and/or vehicle extrication must sign the candidates' practical skills checklists for the specific skills and indicate pass/fail for the skills. The Evaluator completes a "Verification of Successful Completion of Alternative Compliance Method Practical Skills" for each candidate's training record.

Practical skills mandatory live fire compliance methods:

- (1) 5.3.7: Fire Control - passenger vehicle fire
- (2) 5.3.8: Fire Control - exterior combustibles
- (3) 5.3.10: Fire Control - interior structure fire
- (4) 5.3.19: Fire Control: ground cover fire
- (5) 6.3.1: Fire Control - exterior ignitable liquid fire
- (6) 6.3.2: Fire Control - coordinate interior attack team
- (7) 6.3.3: Fire Control - flammable gas cylinder fire
- (8) 6.4.1: Rescue - vehicle extrication

All of the fire control skills must involve live burns. In areas where environmental or other concerns restrict the use of Class A fuels for training evolutions, properly installed and monitored gas-fueled fire simulators can be substituted. Live fires involving the use of portable fire extinguishers are not eligible for an alternative compliance method. If a live fire skill associated with portable extinguisher is on the selected sequence it must be demonstrated during the certification skills exam.

The AFSC approved Evaluator must verify and complete the Practical Skills Certification Exam Check off Forms. The Live Fire/Extrication Certification Eligibility Compliance Method **must be conducted** for each candidate for eligibility to participate in a final certification exam.
