Certification Fee Schedule

DETAILED BREAKDOWN OF FEES

Effective July 1, 2015, the Alaska Fire Standards Council has the following fee schedule in place for testing and certification:

\$25 Written Test- *Single fee for tests taken during the same sitting (e.g. FFI & HMO)*

\$25 Practical Test- *Single fee for combined practical examinations (e.g. FFI & HMO)*

\$25 Certificate Administration Fee- **per certificate issued**

Example - A firefighter testing for Firefighter I with Haz-Mat Aware/Ops will pay \$25 for the FF I and Haz-Mat Aware/Ops written test + \$25 for the FF I and Haz-Mat Aware/Ops practical test + \$25 for FF I Certificate+ \$25 for Haz-Mat Aware/Ops Certificate = \$100 Fee

\$25 Reciprocity – per certificate

Example - A firefighter requesting reciprocity for Firefighter I and Hazardous Materials Awareness/Operations will pay \$25 for FF I + \$25 for HMO = \$50 Fee

- Applications for certification will not be processed until the appropriate fee is received.
- Please make checks or money orders payable to the *Alaska Fire Standards Council*.
- AFSC fees assist with administrative costs associated with the testing and certification process and all fees are **non-refundable**.
- AFSC test fees not paid within 12 months of issuance will result in removal of candidate from the application process and deletion of score results.

SUMMARY OF FINAL EXAM AND PROCESSING FEES BY CERTIFICATION TYPE

Common certification levels/requests:

Firefighter I with Hazardous Materials Awareness/Operations with certificates (written/practical/admins)	\$100
Firefighter I <i>or</i> Firefighter II (no Haz Mat) with certificate (written/practical/admin)	\$75
Firefighter I ONLY with certificate (written/practical/admin)	\$75
Hazardous Materials Awareness/Operations ONLY with certificate (written/practical/admin)	\$75
Fire Instructor I with certificate (written/practical/admin)	\$75
Aircraft Rescue Firefighter with certificate (written/practical/admin)	\$75
Rapid Intervention Technician with certificate (written/practical/admin)	\$75
Fire Officer (written/practical/admin)	\$75
Certification Renewal with no written exam (Fire Instructor, Fire Investigator)	\$25
Basic Firefighter	\$25
Written Retest ONLY(any type)	\$25
Request for certificate copy (<i>per copy with a maximum charge of \$30 per individual file, per each request</i>)	\$15
State of Alaska *Firefighter I or II collar pins (price per pin with 20% discount for 5 or more)	\$5

For Accredited programs the above fees will include all related seals.

** Collar pins will only be issued to AFSC certified FFI or FFII*
