



Certification Fee Schedule

ALL FEES are NON-Refundable

- Applications for certification will not be processed until the appropriate fee is received.
- AFSC test fees not paid within 12 months of issuance will result in removal of candidate from the application process and dismissal of score results.
- AFSC fees assist with administrative costs associated with the testing and certification process.
- Credit/ Debit is preferred, otherwise check/money orders are payable to the *Alaska Fire Standards Council*.

DETAILED BREAKDOWN OF FEES

The Alaska Fire Standards Council has the following fee schedule in place for testing and certification:

\$25 Written Test- Single fee for tests taken during the same sitting (e.g. FFI & HMO)

\$25 Practical Test- Single fee for combined practical examinations (e.g. FFI & HMO)

\$25 Certificate Administration Fee - per certificate issued

Example – A firefighter testing for Firefighter I with Haz-Mat Aware/Ops will pay: \$100 Fee

\$25 Written test FF I and Haz- Mat Aware/Ops

\$25 Practical test FF I and Haz-Mat Aware/Ops

\$25 for Haz-Mat Aware/Ops Certificate

\$25 for FF I Certificate

\$25 Reciprocity – per certificate, up to the highest level within a single standard when evidence of each prerequisite level is clearly met.

Example 1 – The AFSC charges a single \$25 fee for Hazardous Materials Technician (NFPA 472) for requests that include certification documentation for Awareness, Operations, and Mission Specific 6.2 & 6.6). Upon approval the AFSC will recognize and record prerequisite levels in its database as “implied.”

Example 2 – A firefighter requesting reciprocity for Firefighter II and Hazardous Materials Awareness/Operations will pay \$25 for FF II written + \$25 for HMO = \$50 Fee (the AFSC records FFI as implied)

SUMMARY OF FINAL EXAM AND PROCESSING FEES BY CERTIFICATION TYPE

Common certification levels/requests:

| \$10 | State of Alaska *Firefighter I or II collar pins each (25% discount for 5 or more) (<i>effective July 1, 2018</i>) |

For Accredited programs the above fees will include all related seals | Collar pins will only be issued to AFSC certified FFI or FFII
