













## **Sexual Assault Response Team (SART) Training**

Sexual Assault Response Team (SART) Training is an advanced, 4-day course. This course offers an in-depth and multi-disciplinary approach to acute sexual assault cases. It is sponsored by Alaska's Council on Domestic Violence and Sexual Assault in partnership with the Alaska Department of Public Safety, State of Alaska Department of Law, the Alaska Nurses Association, the Alaska Network on Domestic Violence and Sexual Assault, and the Alaska Native Women's Resource Center.

## **Step 1: Who is eligible to attend this training?**

To apply for this course, you MUST meet certain eligibility requirements. To open/view the requirements specific to your discipline, please check the appropriate box below.

## Step 3: What is the cost to attend this training? Are there funds to assist with travel?

There is no registration fee and CDVSA will cover travel and lodging costs for **accepted** applicants traveling from greater than 50 miles from the training site. Per diem is not covered.

After being accepted into the training, participants will be informed about how to arrange travel and lodging in order to have those costs covered.

The link is for the <u>APPLICATION</u> to attend only. Applying does not guarantee acceptance. If you are accepted for the training, you will be notified of your acceptance and will be informed about how to arrange travel and lodging in order to have those costs covered.

## **Step 4: What are the training times and expectations?**

Training will begin at 8:00 a.m. and end at 5:00 p.m. each day, with lunch and breaks scheduled. Attending the 4 full days of training is <u>mandatory</u>, as is completing one online training module prior to the start of in-person training (approx. 1 hour). Accepted attendees should plan to arrive at 7:30 a.m. on November 18, 2025, to sign in.
