	I understand payment of my Alaska Permanent Fund Dividend (PFD) may be delayed if I fail to comply with the sex offender and child kidnapper registration requirements under AS 12.63.											
In accordance with AS 12.63.010(e), registration forms required under AS 12.63.010(b) and annual or quarterly verifications must be sworn to by the registrant. False statements shall subject the registrant to prosecution for perjury.
