25	Police Department identification to obtain treatment not available to
26	the general public in purchasing airline tickets by personal check in
27	violation of Anchorage Police Department regulation 4.15.00.

29	5. On or about May 9, 1981, respondent issued a personal check to
30	Western Airlines, Anchorage in the amount of \$1,176.88 knowing his
31	account had insufficient funds for reimbursement, in violation of
32	Anchorage Police Department regulation 4.00.00.

1	6. On or about June 4, 1981, respondent was terminated for cause
2	from employment as a police officer with the Anchorage, Alaska Police
3	Department.
