ORDER OF REVOCATION

The Alaska Police Standards Council of the State of Alaska, having duly convened on the 2nd day of December 2008, and having reviewed and discussed the Accusation against the Respondent, which was served May 17, 2008, in accordance with AS 44.62.380, takes official notice that a Notice of Defense or a Request for Hearing has not been received from Respondent as required by AS 44.62.390. The Council also takes official notice that under AS 44.62.530, if the Respondent does not file a Notice of Defense, the Council may take action based upon other evidence and an Accusation may be used with notice to the Respondent.


Accordingly, the Council has considered the Accusation dated March 19, 2008.

1. That the allegations made in the Accusation against the Respondent dated on the 19th day of March 2008 are hereby adopted and the Accusation is made, by reference, a part of this Order as though set forth fully herein.
2. That the Respondent's police officer certificate in the State of Alaska is hereby revoked; and
3. That this Order of Revocation shall take effect in accordance with AS 44.62.520(a).

Terry Vrabec, Administrator of the Police Standards Council, Department of Public Safety of the State of Alaska, is seeking to revoke the police officer certificate of Junior Anthony (hereafter the respondent) under the legal authority of AS 18.65.245(2) and the Council's regulations in 13 AAC 85.010(a) and (b), and 13 AAC 85.110(a), (b), and (c) under the procedures governed by the Administrative Procedure Act in AS 44.62.330, *et. seq.* The administrator alleges as follows:

1. On or about August 8, 2004, the respondent was hired as a police officer for the Department of Public Safety.
2. On or about October 4, 2004, the respondent submitted an application to the Alaska Police Standards Council (APSC) for a police officer certificate.
3. That on or about October 4, 2004, the respondent was certified as a police officer in the State of Alaska.
4. That on or about April 30, 2007, at or near Fairbanks, Alaska, the respondent did knowingly and unlawfully engage in sexual contact with A.L. without her consent.

11. The respondent's conviction for Sexual Abuse of a Minor in the Fourth Degree is a "crime involving domestic violence" pursuant to AS 18.66.990(3)(A) and(5)(H).

12. As a result of his conviction for Sexual Abuse of a Minor in the Fourth Degree, the respondent is required to register as sex offender for 15 years following his release from incarceration.

13. Based on the respondent's conduct outlined above, the respondent demonstrated poor moral character which cannot be tolerated by a certified police officer in Alaska.

COUNT I

Paragraphs 1 through 10 are incorporated by reference. Based upon these facts, the respondent's conviction for a misdemeanor crime involving domestic violence is grounds for mandatory revocation under 13 AAC 85.110(b)(1).

COUNT II

Paragraphs 1 through 10 are incorporated by reference. Based upon these facts, the respondent's resignation under threat of discharge for cause relating to misconduct is grounds for mandatory revocation under 13 AAC 85.110(b)(3).

COUNT III

Paragraphs 1 through 10 are incorporated by reference. Based upon these facts, the respondent's resignation under threat of discharge for cause

5. During a recorded telephone conversation between the respondent and A.L. on May 4, 2007, the respondent apologized to A.L. and stated, "I touched you inappropriately".

6. When respondent was questioned about his conduct with A.L. on May 5, 2007, by Trooper David Wilson during the criminal investigation, the respondent admitted to touching A.L. on her chest.

7. On May 6, 2007, the respondent was charged with two (2) counts of sexual assault in the second degree in case no.4FA-07-01402 CR.

8. On May 7, 2007, the respondent resigned in lieu of termination from the Department of Public Safety.


9. On May 11, 2007, the respondent was indicted for two counts of sexual assault in the second degree; Count I charged that the respondent touched A.L.'s breast without her consent and Count II charged that respondent touched A.L.'s genitals without her consent.

10. On August 11, 2007, the respondent was charged in case number 4FA-07-2694 CR with the crime of violating the conditions of his release in the sexual assault case.

11. On November 1, 2007, the respondent was convicted of one count of Sexual Abuse of a Minor in the Fourth Degree, contrary to AS 11.41.440(a)(2), and one count of violating the conditions of his release, contrary to AS 11.56.757.
