

SEX OFFENDER/CHILD KIDNAPPER ACKNOWLEDGMENT OF REQUIREMENTS AND DUTIES

As a registered sex offender or child kidnapper where "residence" means the physical location of my home or other place where I am living, I understand I am required by law to abide by the following:

Initial
1. I must provide written notice of a change in residence to the Alaska State Trooper post or municipal police department located nearest to my new residence, or to the Alaska Sex Offender/Child Kidnapper Central Registry Office if I reside within the Municipality of Anchorage, by the next working day following the change.

2. I must provide written notice of establishment of or change to an email address, instant messaging address, or other Internet communication identifier to the department by the next working day following the change.

3. Changes that occur during the registration period other than those mentioned above must be reported no later than my next registration verification.

4. If I move out of Alaska I must comply with the registration requirements of the jurisdiction I am moving to and I must provide proof that I am not physically present in Alaska before my information will be removed from the Alaska Sex Offender/Child Kidnapper Central Registry.

Duties Specific to 15-Year Registrants

Initial
1. I understand that if I have been convicted of a single sex offense committed before January 1, 1999, or a single non-aggravated sex offense or child kidnapping committed after January 1, 1999, my duty to register ends 15 years following my unconditional discharge for the sex offense or child kidnapping requiring registration only if I have provided proof acceptable to the department of the unconditional discharge.

2. I understand that I must verify my registration information annually during the calendar month determined by the Alaska Sex Offender/Child Kidnapper Central Registry.

3. I understand that an additional twelve months will be added to the duration of my registration for each calendar year I am, for a total of 30 or more days, either incarcerated or noncompliant with the requirements of AS 12.63.

Duties Specific to Lifetime Registrants

Initial
1. I understand that if I have been convicted of two or more sex offenses committed before January 1, 1999, I must verify my registration information on an annual basis as long as I live, work, or attend school in Alaska.

2. I understand that if I have been convicted of an aggravated sex offense, two or more sex offenses, two or more child kidnappings, or one sex offense and one child kidnapping, committed after January 1, 1999, I must verify my registration information on a quarterly basis as long as I live, work or attend school in Alaska.

3. I understand that I must verify registration information during each quarterly month as determined by the Alaska Sex Offender/Child Kidnapper Central Registry as long as I live, work or attend school in Alaska.

Penalties

- _____
Initial
1. I understand that if I fail to comply with the sex offender and child kidnapper registration requirements under AS 12.63, including timely submission of registration verification information, I will be placed in noncompliant status and shall be subject to prosecution under AS 11.56.835 or AS 11.56.840.
- _____
Initial
2. I understand that payment of my Alaska Permanent Fund Dividend (PFD) may be delayed if I fail to comply with the sex offender and child kidnapper registration requirements under AS 12.63.
