ACCUSATION

Jack W. Wray, Administrator of the Police Standards Council, Department of Public Safety of the State of Alaska, moves to revoke the certificate of Charles E. Betts, as a police officer pursuant to AS 18.65.240(a)(2), AS 18.65.240(c), AS 18.65.270, AS 44.62.330 <u>etc seq</u>., 13 AAC 85.010(a)(3), 13 AAC 85.010(b)(2), 13 AAC 85.110(a)(2), 13 AAC 85.110(a)(3), 13 AAC 85.110(a)(2) and 13 AAC 85.110(a)(3).

The Administrator alleges as follows:

1. On or about February 2, 1974, the respondent was hired as a police officer for the Anchorage Police Department.

2. On or about September 30, 1975, the respondent submitted an application to the Alaska Police Standards Council (APSC) for a police officer certificate.

3. On or about October 2, 1975, the respondent was certified as a police officer in the State of Alaska.

4. On or about October 24, 1991, a 17 year female reported to the Anchorage Police Department that between approximately 1982 and 1987 she had been sexually abused by the respondent. 5. On or about November 4, 1991, the respondent admitted in a statement to investigators of the Anchorage Police Department, that he had sexual contact with the victim on two occasions when the victim was about eleven or twelve years old.

6. On or about November 22, 1991, a department internal investigation was completed and the conclusion was that the respondent "violated Anchorage Police Department Regulation 1.01.040 B prohibiting employees from violating any laws, statutes, or ordinances, that he has violated Anchorage Police Department Regulations 1.02.000 addressing the Law Enforcement Code of Ethics, specifically, '... I will be exemplary in obeying the laws of the land ... 'and that his actions were in violation of Anchorage Police Department Regulations 1.02.080 addressing conduct unbecoming a police employee."

7. On or about December 17, 1991, Captain George S. Novaky, Commander of Anchorage Police Department Staff Services prepared a memorandum stating that the internal investigation conducted in this matter was reviewed by four executive officers of the Anchorage Police Department and the charges were sustained.

8. On or about December 2, 1991, the respondent resigned from his employment as a police officer for the Anchorage Police Department.

COUNT I

9. Paragraphs 1 through 8 are incorporated by reference as though set forth in detail. In addition, the Administrator alleges that the conduct described in paragraphs 4-8
