Instrument placed in service on 6/30/2025. Prior to it being put into service the instrument experienced 4 internal standard errors on VOCs, 3 on 6/18/2025 and 1 on 6/19/2025. The VOC on 6/30/2025 passed. The instrument then had internal standard errors on VOCs on 7/18/2025, 7/21/2025, and 7/28/2025. No breath tests were conducted on the instrument while it was at the agency. This instrument was effectively not in service, and is being deemed "Out of Service" on 06/30/2025, the same date of the In Service Change In Instrument Status Form (100675-2025-07-14-Change-In-Status).
