# Instructions for Completing Equipment Retention/Disposal Certification Form

(HINT: Complete the \*'d items below and then make copies of the form for future reporting.)

### **HEADING**

\* Subgrantee: This is the agency to which the grant award was made.

\*Subaward Number: This is the grant number assigned to the project by CDVSA. It can be found on the Grant Agreement.

\*Project Title: This is the name of the project which is defined which is identified on the Grant Agreement.

\*Project Duration: This is the period of the grant award, not the time period for which this report is being submitted. It can be found on the Grant Agreement, and is changed only if the project requests and receives a grant extension.

Prepared By: This is the person completing this form. Include this person's 10-digit phone number.

Date: This is the date this form is completed.

**Type of Report:** Check the box for which report is being submitted: 1) Upon procurement of the new equipment; 2) at the end of the Grant Award period; or 3) final disposition of the equipment or when the item has depreciated to less than \$5000. 2 & 3 may be combined if the equipment's final disposition coincides with the end of the Grant Award period. If the equipment reaches final disposition prior to the end of the Grant Award period, #3 is not required.

Retention: Check this box if the equipment has a value of less than \$5000 and will be retained, or <u>\$5000 or greater</u> and your agency will retain the equipment and continue to use it for the purposes of the grant for which it was acquired or for other activities currently or previously supported by a Federal agency. Select the box to indicate how the equipment will be used.

- Subgrantees are permitted to make equipment available for use on other projects or programs currently or previously supported by the
