Sgt. Miller,

I looked at the test data from 100351 being in service at AST/Soldotna since 2023.03.24. There were 6 occurrences of interference detected on external standards (2024.04.19, 2024.04.20, 2024.04.20, 2024.04.24, 2024.05.10, 2024.05.11). In each of these occurrences filter 2 was elevated and caused the interference detected status messages on the external standard. The last tank change occurred on 2023.012.16. Paulyne is mailing you a new tank this week, per your request. I'd like you to change the tank as soon as you get it and we'll keep an eye on your instrument for an additional two weeks. If the status messages continue we can swap your instrument out.
