#### STATE OF ALASKA Alaska Police Standards Council Minutes of the 140th Regular Meeting March 30, 2021 Statewide Teleconference

## 1. CALL TO ORDER

Chair Doll called the 140<sup>th</sup> Regular Meeting of the Alaska Police Standards Council to order on March 30, 2021, at 12:00 p.m. A roll call was conducted as follows:

### 3. APPROVAL OF AGENDA

Deputy Commissioner Morgan requested that Item 9 on the agenda, Regulation Change Project No. 2020200735, be taken up later in a special session of the Council and be removed from today's agenda. He explained that that would allow sufficient time for a thorough discussion of the matter and for thorough consideration of the extensive public comment received.

It was moved by Morgan and seconded by Dutra to approve the agenda as <u>amended.</u> The motion passed with unanimous consent.

### 4. <u>APPROVAL OF PAST MINUTES – December 1, 2020</u>

It was moved by Morgan and seconded by Dahlstrom to approve the minutes of the 139<sup>th</sup> Regular Meeting held December 1, 2020. The motion passed with unanimous consent.

### 5. PERSONS TO BE HEARD

Molly Brown stated that she will present her comments later at the special meeting of the Council when it takes up the regulation change matter as that is what her comments pertain to.

Malan Paquette stated she is a life-long Alaskan and strongly supports law enforcement. She noted that Senate Bill 92 currently before the Legislature is seeking to bring Alaska's protocol regarding missing persons under 21 years of age up to Federal standards. She strongly encouraged the Council to provide its support in favor of the passage of Senate Bill 92.

## 6. COUNCIL CHAIR'S REPORT

Chair Doll announced that he will be retiring in June, at which time Vice-Chair Hamon will become Chair of APSC.

## 7. EXECUTIVE DIRECTOR'S REPORT

The March 30, 2020, Executive Director's Report to Council was distributed to Council members prior to the meeting and is available online.

ED Griffiths welcomed new Council member Greg "Scott" Campbell, replacing Wendi Shackelford as a public member. ED Griffiths also welcomed APSC's new training coordinator Greg Stocker. Mr. Stocker brings with him a lot of training expertise, and as he is in Anchorage and on the road system, he will be able to travel to many more departments than the prior training coordinator in Juneau was able to.

## 8. <u>NEW BUSINESS</u>

### a. APSC Basic Academy Funding

ED Griffiths noted that two years ago the Legislature put into APSC's budget the specific legislative intent that said, "It is the intent of the Legislature that you do not use APSC funds for paying for basic training for municipal officers." That, coupled with past severe funding shortages, led APSC to discontinue prepaying the Basic Academy tuition for municipal officers. ED Griffiths reported that APSC is now in a better financial position to revisit the issue of Basic Academy funding in part due to the increase in surcharge rates and also due to the cancellation of training last year due to COVID.

The Council then discussed various ways this additional revenue could benefit police agencies with their training needs. With the upcoming proposed regulation changes which could potentially require increased inservice training around the state for officers to maintain their certifications, the importance of ensuring there are sufficient funds for continued inservice training was noted. Following further discussion, Chair Doll suggested the matter be tabled pending finalization of the proposed regulation changes as that will give the Council a better idea of future inservice training needs. ED Griffiths stated he will put together a draft policy regarding Basic Academy and in-service training that can be discussed at the next regular Council meeting.

## 9. OLD BUSINESS

## a. Regulation Change Project Number 2020200735

Per the prior motion, this matter will now be taken up in a special session of the Council.

# 10. ADJOURN TO EXECUTIVE SESSION

It was moved by Morgan and seconded by Dahlstrom to adjourn to Executive Session to address subjects that may tend to prejudice the reputation and character of individuals and for deliberations on adjudicatory proceedings in APSC cases: 2015-02, 2018-20, 2019-05, 2019-24, 2019-35, 2020-05, 2020-16, 2016-27, 2020-15, 2020-24, 2020-26, and 2019-16. The motion passed with unanimous consent. General session ended at 12:40 pm.

Following deliberations during Executive Session, Chair Doll called the General Session back to order at 1:55 pm.

A roll call vote was taken. The motion passed unanimously with two recusals: Morgan and Campbell.

**2019-24 Brent Bartlett**: <u>It was moved by Morgan and seconded by</u> <u>Winkelman to accept the surrender of his certification.</u> A roll call vote was taken. The motion passed unanimously with two recusals: Mercer and Campbell.

**2019-35 Charles Jetton**: <u>It was moved by Winkelman and seconded by</u> <u>Dutra to accept the surrender of his certification.</u> A roll call vote was taken. The motion passed unanimously with three recusals: Morgan, Nicholson, and Campbell.

**2020-05 Martin Oulton**: <u>It was moved by Hamon and seconded by</u> <u>Morgan to accept the surrender of his certification.</u> A roll call vote was taken. The motion passed unanimously with one recusal: Campbell.

**2020-16 Angela Lincoln**: <u>It was moved by Dutra and seconded by Mercer</u> to accept the surrender of his certification. A roll call vote was taken. The motion passed unanimously with three recusals: Knapp, Campbell, and Winkelman.

**2020-15 Jerry Gogo**: <u>It was moved by Mercer and seconded by</u> <u>Winkelman that the APSC has determined there is probable cause to move</u> <u>forward with revocation proceedings.</u> A roll call vote was taken, and the motion passed unanimously with one recusal: Campbell. **2020-24 Nathan Keays**: <u>It was moved by Dutra and seconded by White</u> <u>that the APSC has determined there is probable cause to move forward</u> <u>with revocation proceedings.</u> A roll call vote was taken, and the motion passed unanimously with two recusals: Campbell and Doll.

**2020-26 Craig Bales**: It was moved by Hamon and seconded by Mercer that the APSC has determined there is probable cause to move forward with revocation proceedings. A roll call vote was taken, and the motion passed unanimously with four recusals: Dahlstrom, Knapp, Campbell, and Winkelman
